BASIC GUIDELINES FOR FOSTERING

1. The dog in your foster care has been vetted and has received the necessary shots. If any additional medical procedures are needed, you will be asked to take the dog for the appointment. **Another Chance RFT will only pay for appointments which are scheduled by them.**
2. If your foster gets sick during the time in your home, please contact Tana Neel (361-205-0222).
3. Until you know the personality of the dog, please crate him/her while you are not at home. This will insure the safety of the dog and the safety of your house. When you are secure in knowing that the dog will be fine loose, you may leave him/her out of the crate.
4. The foster dog in your care, should **NEVER** be allowed off leash unless he/she is in the safety of your fenced, secure yard or in your house. IF you wish to take them to an OFF LEASH DOG PARK, please check with Another Chance RFT first.
5. Collars and ID tag should be on your foster at all times.
6. If anyone is interested in the dog in your care and wishes to adopt him/her, they should be directed to Another Chance RFT/ **IF THE DOG IS ALREADY PROMISED TO A RESCUE, HE/SHE CANNOT BE ADOPTED WITHOUT CONSENT OF THE RESCUE.**

ANOTHER CHANCE RFT WILL PROVIDE A CRATE, BEDDING, FOOD, BOWLS, COLLAR, AND LEASH IF YOU NEED ANY OF THESE ITEMS. IF AT ANY TIME, YOU CANNOT CARE FOR THE DOG, PLEASE CONTACT US IMMEDIATELY AND WE WILL MAKE ARRANGEMENTS TO MOVE THE DOG.

PLEASE INITIAL EACH ITEM AND SIGN AT THE BOTTOM.
